FINANCES: DETERMINATION OF UPPER LIMITS OF SALARIES, ALLOWANCES AND BENEFITS FOR COUNCILLORS FROM 01 JULY 2013

RECOMMENDATION BY THE EXECUTIVE MAYOR

1. **THAT** Council take note of the report by the Executive Director: Financial Services regarding the determination of upper limits of salaries, allowances and benefits for Councillors from 1 July 2013.
2. **THAT** with effect from 1 July 2013 Councillors be remunerated according to the determination of salaries, allowances and benefits for Councillors as determined per Notice R. 64 in Government Gazette 37281.
3. **THAT** Council take note that the formula to determine the grade of the municipality was applied and has remained on a grade 4.
4. **THAT** prior to the implementation of the upper limits mentioned in paragraph 2 above, the necessary concurrence be obtained from the MEC for Cooperate Governance and Traditional Affairs, Mpumalanga.
5. **THAT** the payment of allowances for part-time Councillors that are Chairpersons of Section 79 Committees be considered at a later stage.
6. **THAT** Council re-prioritise the budget through the adjustment budget to accommodate the additional allowances for part-time Section 79 Committee Chairpersons should Council decide to implement these allowances.
7. **THAT** Council consider the payment of a fixed allowance of not more than R300,00 per month for mobile data cards subject to the submission of proof.
8. **THAT** the financial implications to extend the tools of trade be determined and a phase in approach be followed.
