2. THAT with effect from 1 July 2013 Councillors be remunerated according to the determination of salaries, allowances and benefits for Councillors as determined per Notice R. 64 in Government Gazette 37281.
3. THAT Council take note that the formula to determine the grade of the municipality was applied and has remained on a grade 4.
4. THAT prior to the implementation of the upper limits mentioned in paragraph 2 above, the necessary concurrence be obtained from the MEC for Cooperate Governance and Traditional Affairs, Mpumalanga.
5. THAT a further report be submitted to Council before 31 March 2014 regarding the possible payment of the following:

 - 5.2 Fixed allowances of not more than R300 per month for mobile data cards;
