**RECOMMENDATION BY THE EXECUTIVE MAYOR**

- 1 **THAT** the content of the report by the Acting Executive Director: Corporate Services on the response by the MEC for Corporate Governance and Traditional Affairs (COGTA), be noted.
- 2 **THAT** as per the directive of the MEC for Co-operative Governance and Traditional Affairs, Mr B. Khenisa be appointed as the Acting Municipal Manager from 1 November 2017 for a period of 12 (twelve) months or until the post is properly filled, whichever comes first.
- 3 **THAT** Mr B. Khenisa enter into a contract with the Department of Co-operative Governance and Traditional Affairs and his remuneration be borne by Council to the post of Acting Municipal Manager.
- 4 **THAT** Mr B. Khenisa be remunerated as per the Local Government, Upper Limits of Total Remuneration packages payable to Municipal Managers and Managers directly accountable to Municipal Manager, 206, benefits/allowance, conditions of services.
- 5 **THAT** as per the directive of the MEC, the title of the post of Deputy Municipal Manager be re-instated.
- 6 **THAT** Council further confirms the delegations of powers of the Municipal Manager to the appointed Acting Municipal Manager and the Deputy Municipal Manager.
